I. Call to Order:

a. Roll Call 2021 Board:

A call of the roll indicated that all Board Members were present by live video conference or phone. There being a quorum present, Mark Jackson, President of the Board, called the meeting to order.

- <u>Approval of Minutes:</u> Mrs. Tvergyak-Oznowich introduced Resolution 21-65(A) to approve the minutes for May 19, 2021 meeting. This resolution was approved.
- c. <u>Approval of Donations</u>: Mrs. Tvergyak-Oznowich introduced Resolution 21-06(D) approving donations to the program. This resolution was accepted and approved.
